

**AGREED VALUE REQUEST FORM**

In order for Underwriters to consider applying an “Agreed Value” clause to a policy, it is essential that this form is fully completed by a qualified motor engineer or an appointed club valuation officer and at least six current photos of the vehicle must be submitted. Underwriters will then consider if the valuation is in line with current market trends, and if so, apply the agreed value policy endorsement, or in the unlikely event that the value is not acceptable, Underwriters will agree to cancel the policy pro-rata. Once an agreed valuation has been applied this will be valid for up to three policy terms.
